Assembly Bill (AB) 2880: Increased Training and Fee Increase for Security Guards

Attention: Private Patrol Operators, Training Facilities and Instructors

Due to the passage of AB 2880, additional training became required for security guards, effective July 1, 2004. In addition, the security guard initial registration fee increased effective January 1, 2003 and the security guard renewal fee increased effective March 1, 2003.

AB 2880 was sponsored by Assembly Member Edward Chavez and was signed into law on September 25, 2002, by Governor Gray Davis.

Security Guard Training Requirements

AB 2880 increased the required training for security guards from 3 hours to 40 hours and requires an 8-hour refresher course every 12 months after completion of the 40-hour course.

Effective July 1, 2004, a security guard must complete an 8-hour training course prior to being placed on post. In addition, 16 hours of training is required within the first month and an additional 16 hours within the first 6 months.

A training curriculum has been developed by the Bureau and is available.

Security Guard Fee Increase

AB 2880 included a fee increase from \$40 to \$55 for the security guard initial registration; the security guard renewal fee increased from \$30 to \$40.

Refresher Training Requirement

Effective January 1, 2005, a licensee must annually provide each registered security guard under their employ with eight hours of review or practice in security guard skills.

The required 40-hour training refresher course must be given by the end of the guard's first full calendar year and every calendar year thereafter.
